DEFAULT JUDGMENT

Considering Plaintiff's, QOTD Film Investment Ltd., foregoing "Application for Entry of Final Judgment by Default" (Rec. Doc. 31), supporting exhibits and declaration along with the Clerk of Court's certification of default against Defendant Dylan Walther,

**IT IS ORDERED** that upon application of plaintiff, QOTD Film Investment, Ltd. ("QOTD"), pursuant to Federal Rule of Civil Procedure 55(b)(2) for a final judgment by default in its favor and against defendant, Dylan Walther ("Walther"), and good cause appearing therefore, Plaintiff's application is **GRANTED**.

Accordingly, it is **ORDERED, ADJUDGED, and DECREED** that:

1. Defendant Dylan Walther has willfully infringed the rights of plaintiff QOTD Film Investment, Ltd., in violation of 17 U.S.C. § 501, et seq.
2. Defendant Dylan Walther was properly served by domiciliary service at 102 Choctaw Pl., Mandeville, LA 70471.
3. Defendant Dylan Walther failed to appear and defend in these proceedings.

4. Statutory damages are proper and reasonable in the amount of \$15,000 to compensate plaintiff and to provide notice and to act as a deterrent to others. Accordingly, plaintiff's request for statutory damages is **GRANTED** and an award of statutory damages is hereby entered herein in favor of plaintiff, QOTD Film Investment, Ltd., and against defendant, Dylan Walther, in the amount of \$15,000.00, plus interest as provided by law from date of this judgment until paid.
5. Plaintiff's request for attorney fees is **GRANTED** and an award of attorney fees is hereby entered herein in favor of plaintiff, QOTD Film Investment, Ltd., and against defendant, Dylan Walther, in the amount of \$9,869.00, plus interest as provided by law from date of this judgment until paid.
6. Plaintiff's request for costs is **GRANTED** and an award of costs is hereby entered herein in favor of plaintiff, QOTD Film Investment, Ltd., and against defendant, Dylan Walther, in the amount of \$1,359.32, plus interest as provided by law from date of this judgment until paid.
7. Plaintiff's request for a permanent injunction is **GRANTED**. Dylan Walther is hereby enjoined from, directly or indirectly, infringing plaintiff's rights in the motion picture Queen of the Desert. Dylan Walther shall not reproduce, copy, distribute, upload, torrent, or otherwise make Queen of the Desert available for public distribution,

whether through the internet or otherwise, absent express written permission from plaintiff.

8. **IT IS FURTHER ORDERED** that Dylan Walter destroy all illegally obtained copies of Queen of the Desert in his possession, custody, or control, including both electronic files and any copies transferred onto any physical medium or device; delete all software used to exchange unlicensed media content, such as BitTorrent protocol, used to obtain or distribute copies of Queen of the Desert; refrain from knowingly and willfully using BitTorrent or any other online media distribution system for copying or downloading content in violation of United States Copyright laws.
